Bertolak ke Lapangan Terbang Tashkent untuk menaiki penerbangan domestik ke Urgench.

Setibanya di Urgench, bertolak ke Khiva. Lawatan ke:

- **Ichan Qala**, bandar tertua di Uzbekistan yang mempunyai banyak monument seni bina berabad-abad lamanya, bangunan yang kukuh, istana, masjid, madrasah, makam, menara, karavan-sarai, dan rumah mandian.

Makan malam dan daftar masuk hotel. Bermalam di Khiva

HARI 3 KHIVA BUKHARA

Sarapan pagi di hotel dan daftar keluar.

- Bertolak menuju ke Bandar Bukhara dan akan melalui padang pasir Kizilkum. Dalam perjalanan, dapat menikmati pemandangan Amu Darya River, Sungai terdalam di Asia Tengah yang terbentuk oleh pertemuan Panj dan Vakhsh di Tajikistan dan mengalir ke Laut Aral.

Setibanya di Bukhara, mempunyai masa bebas.

- **Ark of Bukhara**, kota pertahanan dan kediaman rasmi diraja yang masyhur yang dibina sejak abad ke-5 oleh Putera Parsi Siyavusha.
- **Samanid Mausoleum** yang dibina seawal kurun ke 10 dan juga Chashma Ayub, yang bermaksud perigi Ayub, dan masjid Bolo-Hauz yang dibina pada tahun 1712 dan disenaraikan sebagai salah satu Tapak Warisan Dunia UNESCO.
- **Nadir Divan Begi**, salah satu madrasah terkenal di Bukhara yang dikenali sebagai yang juga merupakan sebahagian daripada Lyabi House Ensemble (dataran utama di Bukhara – takungan buatan terbesar pada zaman pertengahan Bukhara).
- **Poi Kalon Complex**, kompleks bangunan yang terdiri dari 3 bahagian, Kalan Mosque, Kalan Minaret, dan Miri Arab Madrasah.

Makan malam dan bertolak pulang ke hotel. Bermalam di Bukhara.

HARI 5 BUKHARA

SP/MT/MM

Sarapan pagi di hotel. Lawatan di Bukhara:

- **Bahauddin Naqshbandi complex**, dibina sebagai memperingati tokoh ulamak sufi yang terkenal, Syekh Bakhaududin Nakshbandi yang mangkat pada tahun 1389. Kompleks ini terdiri daripada sebuah madrasah, sebuah menara dan dua buah masjid.
- **Sitorai-Mokhi-Khosa palace**, Istana Musim Panas pemerintah Bukhara yang siap dibina pada tahun 1917 dan dinamakan sempena nama isterinya dan sejurus selepas kejatuhan Emirat Bukhara pada tahun 1727, Istana ini diubah menjadi sebuah muzium.
- **Chor Bakr Memorial Complex**, dibangunkan di tempat perkuburan Abu Bakar Said yang mangkat pada tahun 971 dan mempunyai nasab keturunan Nabi Muhammad SAW.

Makan malam dan bertolak pulang ke hotel. Bermalam di Bukhara.

HARI 6 BUKHARA - SHAHRISABZ - SAMARKAND

Sarapan pagi dan daftar keluar hotel. Bertolak ke Shahrissabz, tempat kelahiran Amir Timur, Penakluk Abad ke-14 Asia.

Lawatan di Shahrissabz:

- **Ak Saray Palace**, istana yang musnah dan merupakan tapak bersejarah di Shahrissabz. Ianya dibina pada abad ke-14 dibawah pemerintahan Amir Timur (Tamerlane). Pada tahun 2000, istana ini telah diistiharkan sebagai Tapak Warisan Dunia UNESCO.

- **Jahongir Mausoleum**, didedikasikan untuk anak sulung Amir Timur yang meninggal dalam pertempuran ketika berumur 20 tahun dan pemerintah berkabung untuk masa yang lama - dipercayai kesedihan berlarutan selama 30 tahun.
- **Dorus Siadat** dan **Dorus Tillavat**, merupakan kompleks peringatan dimana semua keturunan dan kerabat Amir Timur telah dikebumikan.

Bertolak ke Samarkand.
Makan malam dan daftar masuk hotel. Bermalam di Samarkand.

HARI 7 SAMARKAND SP/MT/MM

- Sarapan pagi di hotel.
- Lawatan sekitar Samarkand, terletak di Lembah Sungai Zerafshan, ia adalah bandar kedua terbesar di Uzbekistan yang berusia sama tua dengan Babylon dan Kota Rom:
- **Registan Square**, Kompleks yang menempatkan 3 buah madrasah iaitu Ulugbek Madrassah, Sher Dor Madrassah, Tilla-Kari Madrassah. Madrasah ini masing-masing dibina antara abad ke-15 hingga ke-17.
 - **Shah-i Zinda**, Sebuah kota yang merangkumi kediaman, pemakaman dan masjid untuk keluarga diraja Dinasti Timurid yang dibina sedari abad ke-11 lagi. Makam pertama yang terdapat di sini dikatakan milik saudara Rasulullah SAW yang datang ke kota ini pada abad ke-7 bagi menyebarkan agama Islam.
 - **Bibi-Khanyam Mosque**, dikatakan ianya dibina daripada harta rampasan pencerobohan Timur ke atas India. Pada abad ke-15 ia merupakan salah satu masjid terbesar dan tersergam indah di dunia Islam. Menjelang pertengahan abad ke-20 mengalami kemusnahan besar, tetapi kini sebahagian masjid telah dipulihkan.
 - **Gur Emir Complex** yang dianggap karya agung dalam senibina islam dan di mana terletaknya makam Amir Timur dan keturunannya.
- Makan malam dan bertolak pulang ke hotel. Bermalam di Samarkand.

HARI 8 SAMARKAND - TASHKENT SP/MT/MM

- Sarapan pagi dan daftar keluar hotel. Lawatan di Samarkand:
- **Observatory of Ulugbek**, dibina pada abad ke-15 oleh Ulugbek, salah seorang pemerintah dan ahli astronomi terkenal.
 - Dibawa ke deretan kedai tempatan yang dikelilingi oleh kedai cenderamata, kedai teh, dan sebagainya. Kemudian anda mempunyai masa bebas untuk membeli – belah di sekitar **National Bazaar Siab, Oriental Bazaar**, di mana anda boleh mencari produk buatan tangan tradisional Uzbekistan dan manisan tempatan.



- **Carpet Factory**, kilang permaidani buatan tangan yang unik di mana lebih 400 wanita menjahit permaidani dengan menggunakan teknik tradisional.
- Bertolak ke Tashkent dengan menaiki kereta api. Setibanya di Tashkent, makan malam dan daftar masuk hotel. Bermalam di Tashkent.

HARI 9 TASHKENT - CHINGAN MOUNTAINS - TASHKENT SP/MT/MM

- Sarapan pagi dan daftar keluar hotel. Bertolak ke Chingan Mountains, lawatan ke:
- Menuju ke **puncak Beldersey** dengan menaiki chair lift, anda berpeluang untuk menikmati pemandangan panorama dan berfoto di kawasan pergunungan bertasik.
 - **Charvak Lakeside** untuk masa bebas melakukan aktiviti air (mengikut musim & atas perbelanjaan sendiri).

 - Bergambar di **Sharjah Museum of Islamic Civilization**, muzium yang dibuka pada tahun 2008 yang merangkumi budaya Islam, dengan lebih daripada 5,000 artifak dunia Islam, termasuk kaligrafi, lukisan, seramik, koin, kaca, manuskrip, hasil kerja logam dan peralatan saintifik.
 - Membeli-belah cenderahati dan barangan tempatan di **Blue Souk** dan **Souk Al Arsah**.
- Bertolak ke Lapangan Terbang Sharjah untuk menaiki penerbangan pulang ke Kuala Lumpur

The purchase of Group Tours & Series Group Tours offered by **Wan Vacation Sdn Bhd** branded as **selamatbercuti.com** ("WVSB") constitutes a contractual agreement between you (also referred to as "Tour Member") and WVSB, and represents your acceptance of WVSB's Terms & Conditions as outlined below.

Tour Member is required to carefully read and understand these conditions prior to confirm your booking. Tour Member warrants that you are authorized to accept WVSB's Terms & Conditions on your behalf and on behalf of all the passengers booked and confirmed by you and named in your tour confirmation. These Terms and Conditions are as follows: -

1. Tour or Package Price Includes

- Where applicable, a return Economy or Business Class Flight Air Ticket which is non-refundable and non-eroutable including Airport Taxes, Fuel Surcharges and other relevant charges imposed by relevant governmental authorities, unless specified otherwise.
- Accommodation and Meals as specified in the Tour Program.
- A child below the age of two (2) years old at the point of flight departure date, is classified as an infant and tour fare will be charged only for the air component or air fares plus relevant taxes, where applicable.
- The air component or air fares varies from airlines to airlines and will be quoted when requested.

2. Tour Price Excludes

- Exclusions from Tour Price varies from packages and products. These exclusions could be referred to the "Package Price Does Not Include" Section of each program. WVSB is only acting as an agency to collect these charges and therefore is subjected to the Terms and Conditions of the respective authorities.

3. Accommodation

- Accommodation is based on half twin share for adults unless Tour Member specifically requested for Single or Triple Occupancy.
- Child fare is based on either with or without extra bed in which case the extra bed may be an additional bed or a roll away as determined by the hotel in accordance to their policy which the Tour Member have agreed to concur.
- Child fare is for children aged from 02 – 11 years of age from the date of departure and will be sharing as a third person in a twin or double bed room of two (2) adults. In general, the age of the child as applied 2 – 11 years applies to most countries but however, where it differs, WVSB will notify the Tour Members through its general publication or Tour Program.
- Where a child is sharing a room with one (1) adult, such condition is deemed as the child fare being calculated as an adult rate or Child Twin Share Basis.
- Single Supplement charge will apply for Tour Member traveling alone in a group. Where requested by Tour Member, WVSB will assist to couple the Tour Member but shall not be responsible if such arrangement are not possible. Any cancellation of confirmed booking by Tour Member resulted from the inability to pair the Tour Member, cancellation charges as stipulated in clause 7 of this term will be enforced.
- Where the name of hotel is indicated in the tour program, WVSB shall endeavour to use its best effort to secure the specified hotel unless for reasons of unavailability or security, an alternate hotel within the same classification shall be confirmed. WVSB shall not be held liable for the change of hotel.

4. Request for Extension / Deviation

- Request for Extension & Deviation from the original flight planned or date of travel is subjected to the Airlines Ticket Restrictions, Terms & Conditions and the applicable charges or additional fares.
- Tour Members is to ensure that such request is made and agreed prior to the confirmation of tour booking.
- In the event the tour booking is made and deposits have been paid, the cancellation of the Tour Booking resulted from the failure to arrange the Extension and/or Deviation, the Cancellation Policy as per Section 7 of this Terms & Conditions shall apply.
- Any extension and / or deviation is at the request of the Tour Member shall be at the Tour Member's sole responsibility and WVSB shall not be held responsible for any inconvenience caused or additional cost incurred resulted from the extension and/or deviation.

5. Booking Fees

- WVSB may participate in Travel Fairs such as Matta Fairs and / or any other events organised by WVSB, the airlines or affiliates.
- A non-refundable booking fee will be collected during these events as scheduled below.
- The amount paid through Booking Fees would be lessen from the amount due for Deposit Payments.

7. Cancellation, Cancellation Fees & Refunds

- Cancellation of Tour Booking could arise under the following circumstances :
 - By failure to abide to the stipulated full payment deadline imposed by WVSB as per clause 6 of this Terms and Conditions.
 - By Tour Member.Notice for cancellation of Tour Booking by Tour Member must be made in writing or email to avoid any miscommunication. The date where the notice is received by WVSB will be the basis for the calculation of penalty charges.
- In the event if cancellation is done 60 days or more before the departure date, the deposit will be refunded less the stipulated administrative charges. (Please refer item 6 referenced to the Admin Charges)
- Where refund is eligible, the processing period by WVSB will be within 60 days from the date of the refund request.
- All deposits and full payments made are non-refundable beyond the Cancellation Period. Exceptions are as follows.
 - Death
 - Hospitalization
 - Medical Reasons – Accompanied by Letter from Hospital (Letters from General Practitioners are not acceptable)
- Exceptions as per Clause 7(d) is subjected to the sole approval from WVSB which highly depended on the airlines and relevant suppliers and such refund, if approved, may differ from the amount Tour Member have paid.

8. Flight Timing and On Time Performance

- Flight timings and schedules are not guaranteed and do not form part of the contract. All flight schedules is subjected to change or cancellation by the Airlines or Regulatory Body of the country. WVSB shall use its best effort to re arrange the Tour or flight enabling the Tour Member to proceed with the Tour.
- Pursuance to item 8(a), WVSB shall not be held liable or responsible for any cancellation or additional charges resulted from such change or cancellation of the flight schedule by the Airline or Regulatory Body.

9. Cancellation of Groups & Series Groups Tours and Its Effects

- Cancellation of the entire Group or Series Tours is possible by either WVSB and / or the Tour Member. Details that encompass such cancellation are as follows.
 - Force Majeure - Act of God & War.
 - Strike, Riot, Civil War or Coup
 - Insufficient number of passengers to form a minimum group size of 20 passengers.
- Further to Clause 9 (a) (i) and (ii), it is agreed that the cancellation of Group or Series Groups will be dependent on the official notices issued for travel restriction by The Malaysian Ministry of Foreign Affairs (herein referred to as "Wisma Putra").
- Further to Clause 9 (b), upon the confirmation and the issuance of the notice by Wisma Putra, WVSB shall offer the Tour Member an alternate destination or process for refund. Where the Tour Member opted for Refund, it is hereby agreed that the processing time for such refund will be within 60 days.
- Cancellation of Group or Series Group further to Clause 9 (a) (iii), WVSB shall refund to Tour Member the Tour Price Paid.
- If the cancellation is being requested by Tour Member for incidents occurred as per Clause 9 (a) (i) and (ii) without the official travel restriction notification issued by Wisma Putra, WVSB reserves the right to approve or reject such refund request from Tour Member and the quantum of refund which may not equal to the amount paid by Tour Member.
- The decision by WVSB shall be final and conclusive.

10. Tour Members Responsibilities

- Passport
 - Tour Members are responsible to ensure that they possess a valid International Passport with at least a minimum validity of 6 months from the date of return.
 - The main page of the passport must be emailed or faxed to WVSB upon receiving the Tour Confirmation enabling WVSB to ensure accuracy of information when creating the flight reservations, issuance of tickets and other tour related documents.
 - Tour Members is also responsible to ensure that they are cleared of being blacklisted by Regulatory Bodies such as Inland Revenue, Banks, Insolvency Department and other bodies which may restrict Tour Member from traveling abroad. WVSB will not be responsible for any refund, change or deferment of travel resulted from such restrictions.
- Visa Application
 - Tour Members are encouraged to process their own visa. Where visa fees are included in the Tour Price, WVSB will assist in the application.
 - It is hereby agreed that WVSB shall not be held responsible or liable for any loss of passport due to any reason whatsoever including but not limited to negligence on the part of WVSB, its employees, agents and servants.
- Where the Visa application is rejected or delayed approval by the foreign mission, WVSB shall not be held liable or responsible for any refund over the Tour Price paid
- Travel Insurance
 - WVSB strongly advise all Tour Members to purchase travel insurance coverage for the duration of their tour through WVSB.
 - Travel Insurance is mandatory as advised by Malaysian Travel & Tour Association. For the purpose of indemnification, in the event Tour Members already have insurance coverage or refuses to purchase insurance, Tour Member are required to sign a disclaimer statement to indemnify WVSB for any unfortunate circumstances that may arise while on tour. Such indemnity form will be provided by our Customer Services Department for Tour Members completion prior to the departure of the tour.
 - Tour Member may be denied travel in the event such indemnity form is not signed and returned. Where such denied travel occurs, WVSB is not liable to any refund or change of travel.

11. WVSB's Rights & Responsibilities

- WVSB and/or its associated agents act only as an agent for the transportation companies, hotel contractors and other principles. Tickets, vouchers and documents are issued subject to those terms and conditions under which there services are provided.
- Tour Members participating in any tour shall be at their own risk. WVSB and / or its associated agents, tour operators shall not be held liable to any person, as a result of any of the followings:
 - Inaccuracy, miss description or changes to any tour and its itinerary
 - Expenses due to delays or changes in transport services, sickness, weather, strikes, war, quarantine or other causes
 - Any damage, loss of baggage/s or other personal effects or accidents. It is the responsibility of the Tour Members to claim from their respective insurance
 - Deportation or refusal of entry of Tour Members by immigration Authorities due to possession of unlawful items or holding improper travel documents or any other causes which are considered as subversive by the local and foreign government concerned.
 - Difficult and uncooperative Tour Members whose act and conduct are unreasonable and detrimental to the enjoyment, interest, well-being and safety of the other Tour Members and the smooth-running of the tour in general will be dealt with by the Tour Manager. The Tour Manager may use his/her discretion and request the difficult Tour Member/s to leave the tour and The Tour Manager's her decision is final and conclusive. WVSB will not refund any uncompleted tour or part of the tour resulted from such dismissal.

12. Amendment to Tour itinerary by the Company

- Information in the brochures / flyers is correct to the best of WVSB's knowledge at the time of printing. WVSB makes reasonable effort to avoid changes in the itinerary and reserves the right to make changes at any time due to unforeseen circumstances, especially during peak periods or in the event of a force majeure.
